## MEMBERSHIP WAIVER

### WAIVER OF LIABILITY AND INDEMNIFICATION AGREEMENT

**WHEREAS**, I, and on behalf of my heirs, agents, assigns, beneficiaries, executors and administrators (“Releasors”), state that I am fully aware and understand that the activities which generally take place on the premises of the Coastal Georgia Gun Club, Inc. (hereinafter “CGGC”) involve all facets of the shooting sports and include, but are not limited to, the use, display and demonstration of firearms, archery equipment and other weapons and that participating in or observing such activities entail inherent risks, both known and unknown, which could result in my bodily injury or death or that of others;

**THEREFORE**, in consideration of being admitted to membership in CGGC and allowed to enter upon and use the premises, facilities and services of CGGC for the purpose aforesaid, and for other good and valuable consideration, I do COVENANT and AGREE as follows:

#### **I, AND ON BEHALF OF ALL RELEASORS, DO HEREBY--**

a. **VOLUNTARILY AND KNOWINGLY ASSUME ANY AND ALL RISKS**, including, but not limited to, death, bodily injury or the loss, damage or theft of personal property associated with or arising from entering upon and using CGGC property or facilities for any purpose; and

b. **ABSOLUTELY AND UNEQUIVOCALLY RELEASE**, save and hold harmless CGGC, the officers, directors and members of CGGC, their sponsors, agents, employees, instructors, assigns and successors in interest (“Releasees”) from any claim, demand or liability (whether claimed by myself or another person or entity) which may arise from any loss, damage, injury or death which I or any of my family members or guests may sustain, as well as any loss, damage or theft of property belonging to me or any of my family members or guests, while on CGGC property; provided that with respect to any particular Releasee only, this provision shall not apply for any acts or gross negligence or intentional, willful or wanton misconduct by that particular Releasee; and

c. **INDEMNIFY AND HOLD HARMLESS** the Releasees for any and all damages or injuries to persons or property caused directly or indirectly by me or any family members or guests while on CGGC property, including any attorney fees and costs incurred in defending any claims arising from such damages or injuries.

**I FURTHER EXPRESSLY AGREE** that this Agreement is intended to be as broad and inclusive as permitted by the laws of the State of Georgia and shall be governed by and interpreted in accordance with the laws thereof and that in the event that any clause or provision herein shall be held to be invalid, the invalidity of such clause or provision shall not otherwise affect the remaining provisions, which shall continue to be enforceable.

**I AGREE THAT I WILL ALLOW** my photograph, picture or likeness and/or voice to appear in any documentary, promotional (including any and all advertisements), television, radio, film coverage of any events or social media without compensation.
