Application Procedures and Fees

The following items must be submitted to the Secretary at the introductory meeting:

- ___ Completed and signed application form.
- ___ Completed and signed waiver form.
- ___ Proof of the applicant's legal ability to own firearms (carry permit or background check).
- ___ Payment in full of first year's membership (pro-rated as applicable – see below).
- ___ Proof of NRA membership.

During the introductory meeting, the Sponsor will introduce the applicant. The Sponsor must be willing and able to attest to the applicant's ability to handle firearms in a safe and responsible manner. The sponsor and applicant must be prepared at the introductory meeting to answer questions pertaining to the applicant's background and membership requirements. The applicant's name will then be published in the monthly Club newsletter as applying for membership to the Club.

The Sponsor must attend the following month's meeting to again speak for the applicant prior to a vote on the applicant's membership request. The applicant will not attend this meeting. If the Sponsor (or a co-sponsor who also has knowledge of the applicant) is not present at that meeting, the vote will be postponed for one month only. If the Sponsor or a co-sponsor is not present at the second month's meeting, the applicant's paperwork and fees will be returned to him. He will be allowed to begin the application process again at a later time that is more convenient to him and his Sponsor.

Within 10 days of voting by the members, the Secretary will mail the applicant a letter stating the outcome of the voting and giving information on scheduling an orientation. If the applicant's request for membership is denied the Secretary will return all paperwork and fees to the applicant.

Reinstatements:

Any member whose dues have lapsed by less than 5 years may be reinstated by completing the application form (no sponsor is required), showing proof of NRA membership and paying the current year's dues (not pro-rated) and a reinstatement fee of \$100.00. Once all fees and paperwork have been received, the Secretary will mail a letter containing information on scheduling an orientation. A membership card and gate combination will be issued upon completion of orientation.

Any member whose dues have lapsed by 5 years or more must complete the application process as a new member (including having a sponsor and showing proof of legal ability to own firearms) and be introduced and voted upon as described above.

Orientation:

All new applicants and reinstated members must attend orientation. This should be arranged within 30 days of being accepted for membership or within 30 days of payment of the reinstatement fee. A membership card and gate combination will be issued upon completion of orientation.

Fees:

Membership dues will be pro-rated based on the date of application as follows:

Date of Application*	Dues
September 1 through November 30	\$200.00
December 1 through February 28/29	\$175.00
March 1 through May 31	\$150.00
June 1 through August 31	\$125.00

*Date of application, not date of membership, is used to calculate pro-rated dues amount.
